Your stock donation will be acknowledged when our broker confirms that the funds have entered our account. The donation date for electronic broker-to-broker transfers is the date that the securities enter the Alameda Food Bank's brokerage account. The donation date for endorsed securities mailed to the Alameda Food Bank is the date that the securities certificates are mailed. The donation date for endorsed securities that are hand-delivered to the Alameda Food Bank or its broker is the date that the securities are received. Please use Registered Mail to securely send endorsed certificates by mail and to firmly establish the donation date.

It is the policy of the Alameda Food Bank to sell donated stock as soon as possible after share transfer occurs. The sale typically occurs the day after shares enter the Alameda Food Bank brokerage account.

The Alameda Food Bank has 501(c)(3) status with the Internal Revenue Service, Tax ID (EIN) 94-2878910. Donations are tax-deductible to the extent authorized by law.
